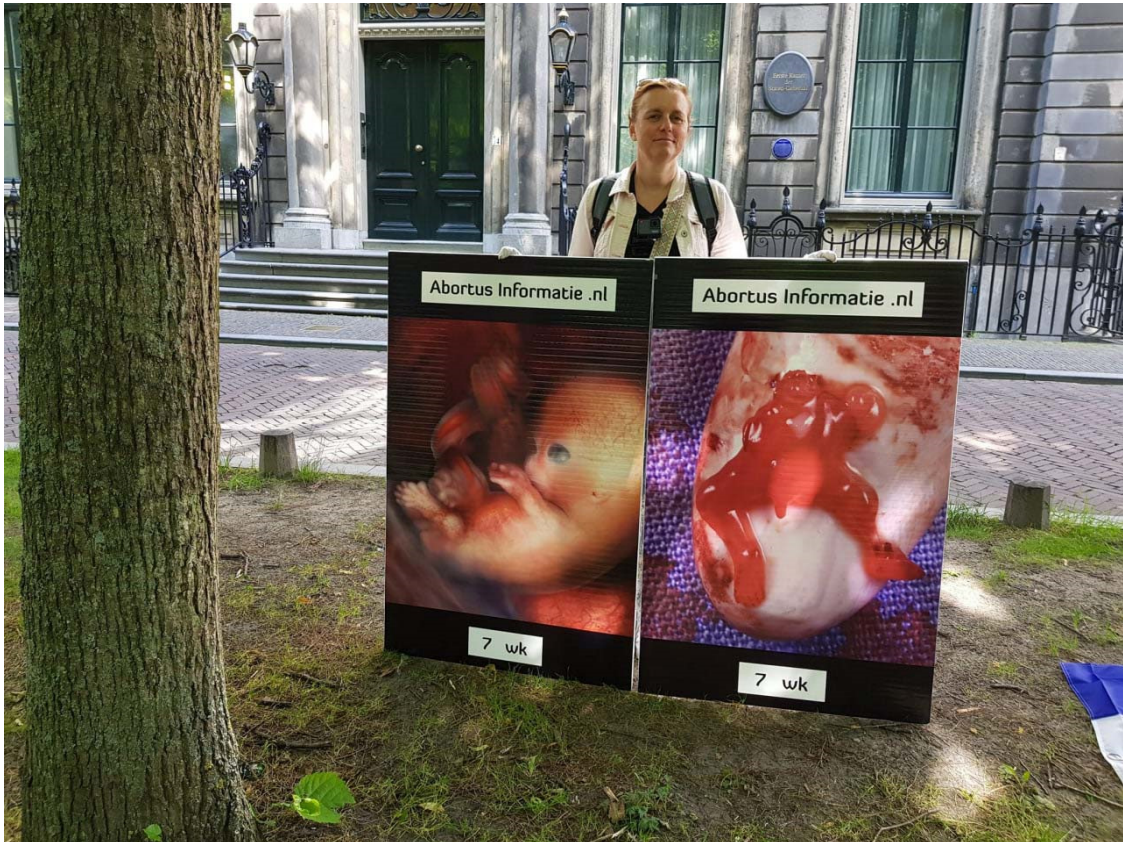

In front of you is our annual report for 2022, in which we give accountability for our income and expenditure in 2022. We publish this annual report for environmental and cost reasons online only.

AbortusInformatie.nl is an innovative human rights NGO organisation that started 40 years after the first abortion clinic opened in the Netherlands, which was the Arnhem Mildredhuis, on 27 February 1971.

Exactly 40 years later, 27 February 2011 AbortusInformatie.nl was launched. AbortionInformation.eu is our English name.

## Human rights organisation

AbortusInformatie.nl is a human rights organisation that educates about abortion.

We are against all forms of violence relating to abortion. Everybody has their own opinion on the topic and different ways of thinking, but violence is not the answer.

Abortusinformatie.nl was set up by women who regret their abortion. We missed crucial information in the decision making process of our abortion.

Many of us say that if we had realized certain things in advance, and seen the images of what babies can look like after enduring an abortion, we would not have made the decision to kill our own offspring through abortion - we would have found other alternatives for the situation we were in.

All board members have affinity with abortion.

We build awareness on the reality of abortion, so that true 'informed consent' can be given based on facts and true understanding.

We do this amongst others by showing medical scientific images.

AbortusInformatie.nl also helps women considering abortion, who decide to keep their baby, or regret their abortion afterwards.

We bring innovative new ideas to the country, and as trailblazers have vision, and are entrepreneurial!

There are no hired employees. Work was carried out by unpaid volunteers. These were engaged in supporting our work for our projects in the short and long term.





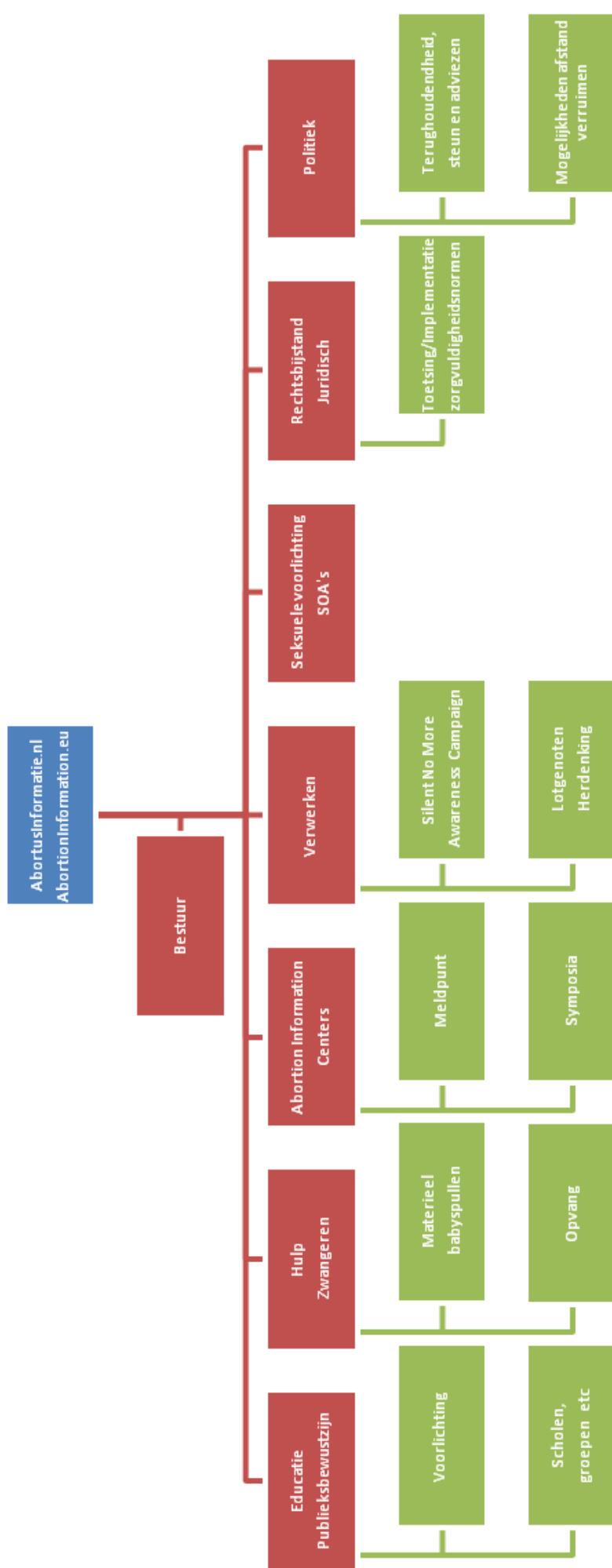
## Strategy

Because we find it inhumane that arms and legs are torn off children, babies are poisoned, starved or beheaded and their lives intentionally prematurely ended through abortion, we started this human rights organization. In Dutch, our foundation is called AbortusInformatie.nl, in English AbortionInformation.eu

1. The goal of the foundation is
  - (a) to be active in the area of human rights, sexuality, abortion and the possible consequences of it, amongst others, by providing information, support and shelter;
  - (b) carry out further actions which, in all senses of the word, relate to or could be conducive to above mentioned areas.
2. The foundation aims to achieve her goals, amongst others, by:
  - (a) providing information and education to promote public awareness on abortion: procedures, consequences, experiences and development of a baby in the womb;
  - (b) supporting women with an unplanned pregnancy (medical, material, financial, emotional and mental help), also after the birth of their baby;
  - (c) offering special provisions and courses for parents and the child, in order to promote their well being;
  - (d) setting up 'abortion information centers', a contact point for forced abortions, and organize platform days, symposia and theme days;
  - (e) providing opportunities for help after abortion (or sexual abuse) through so-called healing groups/retreats, peers' days, commemorative monuments and/or memorial services; the foundation also aims to offer women (post abortion) consolation, information, support and healing;
  - (f) providing sexual education to help prevent unplanned pregnancy (prevention through education), sexually transmitted diseases STD's etc., as well as offering medical diagnosis of STD's and other related diseases;
  - (g) attention to monitoring and ensuring implementation of due care standards surrounding abortion, also availability of an adequate offer of legal assistance with regards to the abortion issue;
  - (h) promoting the kind of legislation and regulations, as a result of which more restraint and a careful approach towards abortion will be taken, with more options coming into being for expectant mothers to give up their (not yet born) baby, as well as issuing advice and proposals to the government in this matter;

all in the broadest sense of the word.

The foundation aims to operate on both micro and macro level. The foundation is open to cooperation with other individuals and/or legal entities as well as with other organizations in the above mentioned areas.



Strategy continued:

The foundation is established for an indefinite period.

The assets of the foundation are to be formed through sponsoring, subsidies, grants, donations, inheritances and legacies and other income resources.

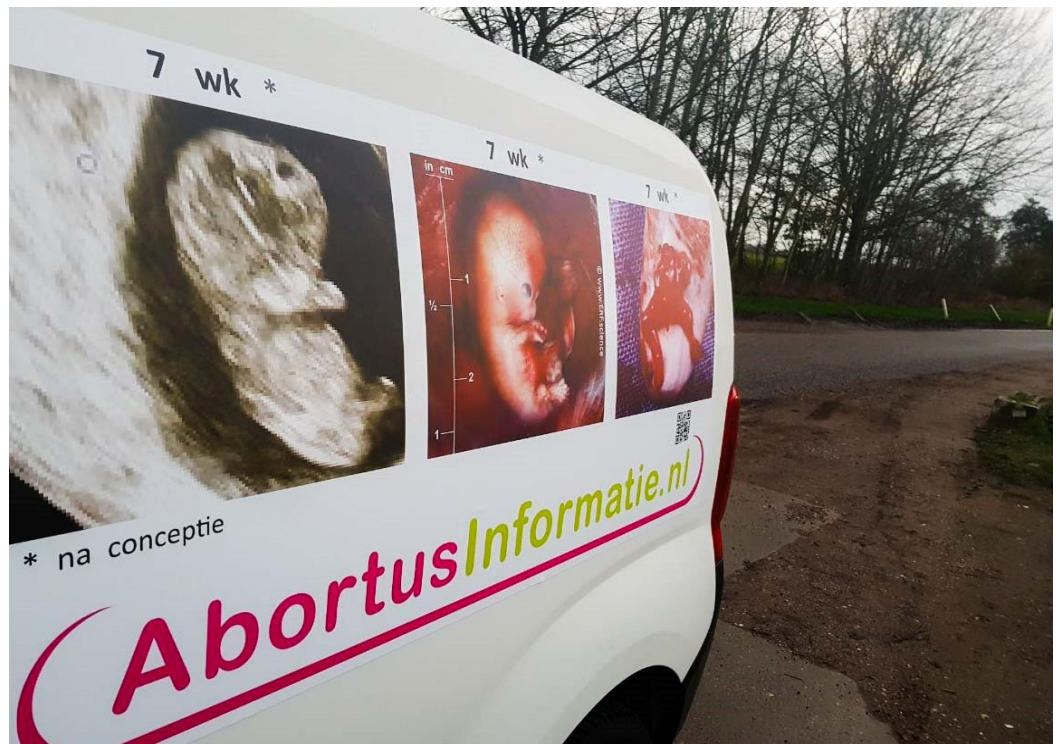

**Inschrijving handelsregister**

De onderneming is ingeschreven in het handelsregister van de Kamer van Koophandel voor Amsterdam onder nummer 51864517

**Doelstelling**

De stichting heeft ten doel: werkzaam zijn op het gebied van mensenrechten, seksualiteit abortus en de mogelijke gevolgen daarvan, door onder andere het bieden van voorlichting hulp en opvang; het verrichten van verdere handelingen, die met het vorenstaande in de ruimste zin verband houden of daartoe bevorderlijk kunnen zijn.

**De stichting tracht haar doel te bereiken door:**

- a) het verstrekken van educatieve voorlichting ter bevordering van het publieksbewustzijn omtrent abortus: procedures, gevolgen, ervaringen en ontwikkeling van een baby in de baarmoeder;
- b) hulp bieden aan vrouwen die ongepland zwanger zijn (zowel medisch, materieel, financieel, emotioneel en geestelijk) ook na de geboorte van hun kind;
- c) het aanbieden van bepaalde voorzieningen en cursussen voor ouders en het kindje, ter bevordering van hun welzijn;
- d) het opzetten van "abortion information centers", meldpunt voor gedwongen abortussen, alsmede het organiseren van platformdagen, symposia en themadagen;
- e) mogelijkheden bieden voor het verwerken van abortus (of seksueel misbruik) door middel van zogenaamde verwerkingsgroepen, lotgenotendagen, herdenkingsmonumenten en/of herdenkingsdiensten; daarbij streeft de stichting ernaar om vrouwen (na een abortus) troost, informatie, ondersteuning en heling aan te bieden;
- f) het verstrekken van seksuele voorlichting ter voorkoming van ongeplande zwangerschappen (preventie en educatie), SOA's, etcetera, alsmede het aanbieden van medische diagnose van SOA en aanverwante ziektes;
- g) zorg te dragen voor toetsing en implementatie van zorgvuldigheidsnormen met betrekking tot abortus, alsmede zorg te dragen voor een adequaat aanbod van rechtsbijstand in het kader van de abortusproblematiek;
- h) het bevorderen van een zodanige wet- en regelgeving waardoor meer terughoudendheid en zorgvuldigheid wordt bewerkstelligd bij een abortus en waardoor meer mogelijkheden ontstaan voor aanstaande moeders om afstand te doen van hun (nog ongeboren) kind, alsmede het ter dier zake uitbrengen van adviezen en voorstellen aan de regering;

Alles in de meest ruimste zin des woords.

De stichting streeft ernaar om werkzaam te zijn op micro niveau en macro niveau. De stichting staat open voor samenwerking met andere natuurlijke personen en/of rechtspersonen danwel andere organisaties op genoemde gebieden.

De stichting is opgericht voor onbepaalde tijd;

Het vermogen van de stichting zal worden gevormd door sponsoring, subsidies en donaties schenkingen, erfstellingen en legaten en andere verkrijgingen en baten.

Het bestuur bestaat uit een voorzitter, secretaris en een penningmeester.

## Comments

The board is grateful for all the generous donations this year, which allowed us to continue this work.

In 2022 we were able to, amongst other things, do the following:

- Advertising campaign social media
- Purchased 18 week baby models for government campaign
- Printed various stickers and cards
- Advertising on van
- Made 6 week baby models for inclusion in government campaign
- Some travel expenses

Along with this, office supplies such as A4 paper, SD's/USB's, operational costs such as websites, phone, admin software, insurance, banking, post office box etc.

## Activities

24.6.2022 marked the day that RoeVsWade abortion was overturned in America. 2 days later, Missouri was the first state to sign papers to end abortion. Many years ago Salome had been asked to help with legislation in Missouri regarding exclusion of babies conceived in violence.

Here in The Netherlands government had numerous debates and voting concerning abortion. AbortusInformatie.nl stood outside the Senate both times with our public education display.

Before voting we sent politicians in Tweede Kamer and Eerste Kamer models of babies 6, 11-12 and 18 weeks from conception, so they would know what they were voting about. The contents of the box catered for the 3 topics: to do away with the 5 day waiting period, make the abortion pill available via the family doctor (instead of just clinic or hospital), and discussions about embryo's.

Kuipers discussed plans to redefine the term 'embryo' to be an 'in tact' or 'not in tact' embryo [for experiments], i.e. not viable, by creating them with no brainstem or spinal cord. We prepared in advance for these discussions.

Only SP 'returned to sender' 'no longer interested in the attached mail item'. Some were positive.

We continued our public education work not only outside government, but with other awareness displays, including a prolife day with the Catholics in The Hague, by the side of the road as Opwekking participants left the camp ground in Biddinghuizen, and in the city of Zwolle. Here the BOA has used his position to intimidate, disrupt, hinder and in the past even prevent a permitted demonstration.

Thankfully after our 3rd request the police were called, who graciously mediated so we could continue our display at the planned location, instead of down the side street—both 50 km per hour roads with traffic lights—but would hardly be able to see our message. We are thankful for all the legal help.

We were asked to give a presentation on abortion to a political party which was held inside the Tweede Kamer in The Hague.

Visited some abortion clinics, eg on International Day of the Unborn Child. Met with a new prolife leader to discuss various issues. Some people gave paintings.

On 11.11.22 we launched our new advertising on the side of a van.

We also ran an advertisement for 7 days on social media, facebook to expand our visibility.

Various babies have been born after contact with us. So wonderful they get to see the light of day. Various requests for help came in, including some requests for AbortusPillStopper (abortion pill reversal). Also offered baby articles.

So wonderful seeing them pregnant, the baby now wanted by both parents.

Work on healing programs continues [www.abortusverwerken.nl](http://www.abortusverwerken.nl), along with various requests that came in as background advisory role for another healing program we helped get started/initially translated.

Traffic to our websites: 2022 saw over 144.000 on our Dutch website, total websites 233.000 came to around 1.3 million views, i.e. between 5.5 and 6 pages per visit.

We were followed by TV program EO Crux, for a special at the beginning of the week for life “Kiezen voor het leven” [https://www.npostart.nl/crux/29-10-2022/VPWON\\_1336231](https://www.npostart.nl/crux/29-10-2022/VPWON_1336231) and can be seen here <https://www.eo.nl/programmas/crux/afleveringen>. Was seen by 436.000 the weekend of airing. How many have watched it afterwards at npostart is unknown. 'Mooi en waardig gedaan.' 'Wat vertelde je op de EO een prachtig en ontroerend levensverhaal Salome. Het emotioneert me...'

Contacted by students of 3 universities for interviews, including a talkshow. An article appeared in Zagreb Croatia. And various google alerts.

One of the responses to our abortion video was: “Everyone should have to watch this before making the decision to have an abortion... that’s one of the most heart wrenching things I’ve ever seen.” World News placed our video on their site

Censorship continues, for example on youtube, twitter, facebook. Apparently you can do it, but you may not show what it's about.

Termed for example

- ‘unnecessary bloodshed’,
- ‘abhorrent violence’,
- ‘gratuitous gore’ (e.g. severe injuries, torture),
- ‘violence against –18s’,
- ‘death, wounds, or someone’s life being threatened’

by social media authorities who have censored us / locked our accounts.

Even now it seems in this document some links no longer work correctly, whereas they did at the moment of initial posting.

Copying the link and manually pasting in browser might work though.

AMBASSADOR OF UNBORN LIFE  
Dutch woman who regrets aborting her own child  
"If I knew the truth, I would never have done it... I will do everything to be the voice of the unborn."

Salome Irene van der Wende is the national coordinator for "Silent No More" in the Netherlands, international speaker for "SaveThe1.com" and the director of "Save the 1 Europe". She also founded organizations with the aim of educating about prenatal life through photographs in order to raise awareness of how unborn children are treated. She personally experienced the drama because after being raped she aborted her child, which she regrets. She later learned from her mother that she herself was conceived in violence.

The Ambassador of the Unborn testifies about her experiences in the media, schools and churches, and also participates in the March for Life. She supports politicians who defend the lives of children conceived in rape and complains to politicians and the media who use situations like hers to advocate legal abortion: "I think it is cruel to condemn innocent children to death for the way they were conceived." She says of her abortion: "If I knew the truth, I would never have done it... I will do everything to be the voice of the unborn." In her song "My baby" she laments her act.

Osobno je proživjela dramu jer nakon što je silovana pobačila je svoje dijete, za čim žali. Kasnije je od majke doznala da je i sama začeta u nasilju. Ambasadorica nerođenih svjedoči o svojim iskustvima u medijima, školama i crkvama, a sudjeluje i u Hođu za život. Podupire političare koji brane živote djece začelih u silovanju i prigovara političarima i medijima koji se koriste situacijama poput njezine da zagovaraju legalni pobačaj: »Smatram da je okrutno što osuđujemo nevinu djecu na smrt zbog načina na koji su začeta.« O svojem pobačaju kaže: »Da sam znala istinu, nikad to ne bih učinila... Učinit ću sve da budem glas nerođenih.« U svojoj pjesmi »My baby« žali za svojim činom.

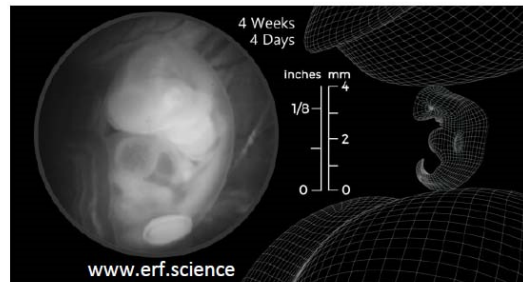
